DOGS ELIGIBLE TO ENTER

This trial is open to all Rhodesian Ridgebacks over the age of 12 months that are registered with the American Kennel Club or are Rhodesian Ridgebacks that have obtained AKC ILP numbers, except bitches in season, aggressive dogs, or dogs suffering from any deformity, injury, or illness which may affect the dog's physical or mental performance. Refer to Chapter 2 of the Registration and Discipline Rules for the listing of registerable breeds that may participate.

HEIGHT DIVISIONS

Owners are responsible for entering the proper height divisions.

JUDGES MUST MEASURE ALL DOGS WHICH HAVE NO AKC HEIGHT CARD PRIOR TO THEIR RUNS.

UNMEASURED DOGS WILL BE ELIMINATED WITH NO REFUND.

24 inches For dogs over 22 inches at the withers

Preferred Jump Heights

20 inches For dogs over 22 inches at the withers in preferred class

RUNNING ORDER

Standard Classes will run Excellent to Novice
Preferred Classes will run Excellent to Novice
JWW Classes will run Excellent to Novice

PRIZES AND AWARDS

Rosettes, a logo laser-etched wood plaque and a logo gear bag will be awarded to the 1st through 4th place dog in each jump height in each class. Qualifying ribbons will be awarded to all dogs receiving a qualifying score. Dogs must qualify to receive placement rosettes and trophies. All prizes must be claimed the day of the trial; none will be mailed.

COURSE FAMILIARIZATION AND WARM-UPS

Handlers in all classes are permitted to walk the course, without a dog, prior to the start of the class. The walk-through allows handlers to plan their strategy for running the course.

Novice A & B dogs and handlers will not be given a familiarization period on each of the contact obstacles.

NOTICE TO EXHIBITORS

The safety of the dogs is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and are able to perform the obstacles safely.

“Exhibitors should follow their veterinarians’ recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.”

Refunds (in full) will be made for notice of a bitch in season received before the closing date. After the closing date, the club will keep a \$5 processing fee and \$5 for each day dog is entered. The balance will be refunded.

Entry fees will not be refunded in the event that a dog is absent, disqualified, excused, or barred from the competition by action of the Trial Committee.

No entry fee will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee.

It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Trial Committee, be asked to leave the trial site. In such case, no refund of any fees paid will be made.

In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons, or trophies, I (we) agree to hold the AKC, the event-giving club, their members, directors, governors, officers, agents, superintendents or event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury or damage to this dog.
