Eligible Breed and Registry

Only Rhodesian Ridgebacks, one year of age or older and who are registered with the American Kennel Club or an AKC recognized foreign registry or have an Indefinite Listing Privilege (ILP), are eligible for an entry. Breed disqualifications apply.

JUNIOR COURSER: (Limited to 50 Dogs per Test) Open to all eligible Rhodesian Ridgebacks. A hound running alone shall receive a certification from a Judge on one date and a second certification from a different Judge at a later date, stating the hound completed a 600-yard course with a minimum of four (4) turns. The hound must complete the course with enthusiasm and without interruption. **The two runs can be on the same date at or in conjunction with a National Breed Specialty.**

- It is highly recommended that Junior Courser hounds entering the open stake for the first time have successful practice experience running with other hounds before competing.

Stakes Offered

OPEN STAKE: Any eligible Rhodesian Ridgeback that has an AKC Field Championship or an AKC Junior Courser Suffix (JC). Conditional entries will not be accepted. Hounds must have one of the above titles prior to the trial closing date or the entry will be rejected.

SPECIAL STAKES: Any AKC Field Champion of Record. LCX points may be awarded from this stake.

OPEN VETERAN STAKE: Open to any Rhodesian Ridgeback who is qualified to enter AKC lure trials. In addition, the hound must be at least 7 years of age on the day of the trial. Championship points will be awarded.

Non-Regular Stakes Offered:

KENNEL STAKE: For two hounds of the same breed, designated at the time of entry, entered in one of the regular stakes, owned and kenneled by the same person.

BREEDER STAKE: For two hounds of the same breed, designated at the time of entry, entered in one of the regular stakes, bred by the same individual.

NOTE: An owner-breeder may have more than one entry in the kennel or breeder stakes as long as the two hounds comprising each entry are properly identified at the time of the entry. A hound may be a part of only one kennel and one breeder entry.

NOTICE TO EXHIBITORS:

All hounds will run twice, in trios, if possible or braces unless excused, dismissed or disqualified. Bitches in season and lame hounds will be excused. Hounds not present at time of Roll Call will be scratched after a 5 minute grace period. Stakes will be split if the entry is sufficient to hold two or more five point majors at the time of the draw. Each entry will be examined at inspection for breed disqualifications. Battery powered, continuous loop lure machines will be used. Backup equipment will be available. The lure will consist of white plastic bags or strips. The course will be reversed for the final courses. The members of the Field Committee reserve the right to alter the course plan as required by weather and/or field conditions on the day of the trial. Exhibitors MUST pick up after their dogs!

NO DOGS ON TRIAL FIELD PRIOR TO EVENT WHATSOEVER!!!
THERE WILL BE A \$5.00 FINE ASSESSED FOR ANY LOOSE HOUND WHICH INTERRUPTS A COURSE IN PROGRESS.

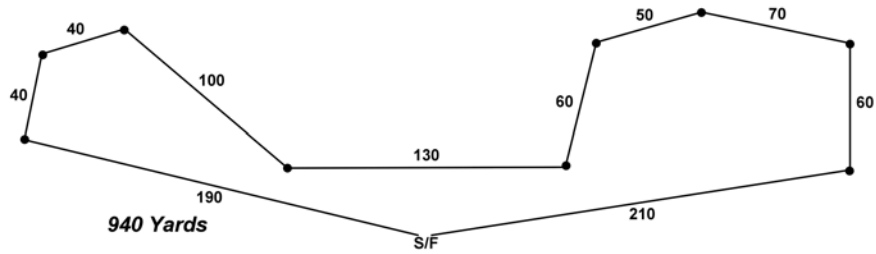

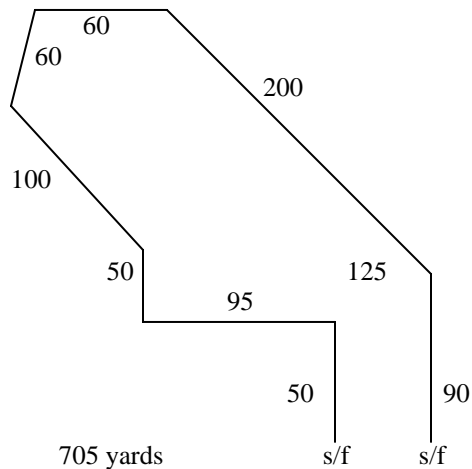
The Park is fenced around the perimeter- 300 + acres. The specific area for both the Test and Trial is an area of rolling terrain. The individual fields are not fenced.
